The purpose of the course work

The main purpose of the course work is to expand, deepen the knowledge and develop the skills in research activities

Topics of course work

The topics of course works are included in the funds of evaluation tools, which are created to certify students for the compliance of their personal achievements with the step-by-step or final requirements of the educational program.

Evaluation tools should provide assessment of the ability of students to creative activity, the readiness of students to search for solutions to new problems associated with the lack of specific specialized knowledge and the lack of generally accepted algorithms.

Course works

The following forms are used to diagnose students' competencies:

- ✓ oral form,
- ✓ written form,
- ✓ oral and written form,
- ✓ technical form.

Written forms of competency diagnostics include:

- ✓ coursework (projects),
- ✓ publications of articles, reports.

The oral and written form of competency diagnostics includes:

- ✓ coursework (projects) with their oral defense.



Criteria for evaluating course works

- ✓ the relevance of the chosen topic;
- ✓ clarity of setting goals and objectives;
- ✓ creative approach to problem solving;
- ✓ the sufficiency of using modern literary sources in the analysis of the research problem;
- ✓ persuasiveness of the system of evidence and scientific argumentation;
- ✓ availability of conclusions based on the results of the study;
- ✓ usefulness and possibility of practical application;
- ✓ compliance with regulatory requirements.



Student survey

Purpose: to analyze the students' experience of performing term papers, to determine the influence of course research on the formation of general and professional competencies of students.

The survey involved 4-year full-time students of the speciality "Speech therapy" of the Institute of Inclusive Education in the amount of 44 people.

The results of the student survey

In their responses, the students noted that the completion of the course work allowed:

- ✓ to gain research experience;
- ✓ to deepen knowledge in the field of special techniques;
- ✓ to study the research problem in detail;
- ✓ to study modern literature on the research topic;
- ✓ to get advice from the head of the course study;
- ✓ to learn how to develop a set of exercises for children aimed at solving a specific didactic problem;
- ✓ to try to present and defend your developments;
- ✓ to analyze the results of the research of their classmates;
- ✓ to participate in a student conference;
- ✓ to learn how to make a list of literature.
